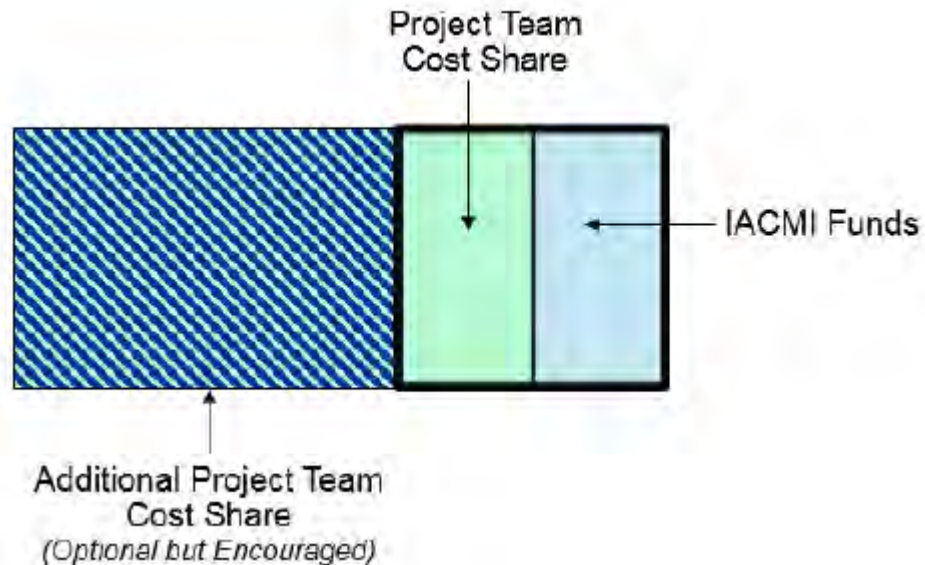
Project Cost Share – How it works

*Additional industry cost share encouraged



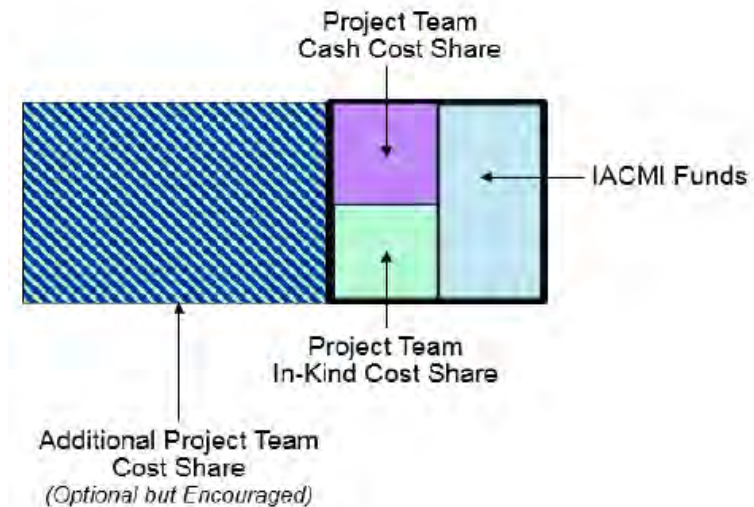
Large Entity Lead –

Types of Cost Share



◆ In-kind cost share

- ◆ Services provided such as time, supplies, travel and equipment
- ◆ For a project, should be directly tied to the budget prepared to support a project.

◆ Cash cost share

- ◆ An actual cash transaction
- ◆ Cash contribution to support project work
- ◆ Helps to meet certain membership requirements (Premium, Charter)

Cost Share Items to Remember



- Retain backup to costshare
- Cannot include profit or fees
- Project cost share needs to include items from the EERE-335 budget only.
- Be sure to complete the cost share form, sign it, and turn it in!
